New Hampshire Insurance Department

- Health insurance companies must provide coverage prior to application of any deductible and without cost-sharing--of the initial health care provider visit and FDA-authorized COVID-19 testing for those who meet the Centers for Disease Control and Prevention (CDC) criteria for testing, as determined by your health care provider.
- If in-network providers are unavailable to conduct testing for COVID-19, insurance companies must cover out-of-network testing. Any prior authorization requirements that typically apply to covered diagnostic tests are suspended with regard to the testing of COVID-19.

• All providers of electric, gas, water, telephone, cable, VOIP, internet, and deliverable fuels service are hereby prohibited from disconnecting or discontinuing service for the duration of the State of Emergency. At the end of the State of Emergency, customers having arrearages accrued during the State of Emergency shall be provided the opportunity to make a reasonable payment arrangement over no less than a six-month period and shall not be charged any fees for late payment for arrearages accrued during the State of Emergency. Unemployment benefits in New Hampshire - minimum unemployment benefits will increase from \$32 to \$168 per week. In addition, individuals will see a weekly boost of \$600, paid with federal funds. Unemployment benefits has been extended 13 weeks, to a total of 39 weeks.

• New Hampshire residents who are laid off, in quarantine, caring for family members or watching over children are now eligible for immediate financial assistance. Individuals with a current diagnosis of the virus; anyone selfquarantined or quarantined at the instruction of a health care provider; anyone caring for a family member who has the virus; anyone caring for a family member because of the closure of a school or business; anyone who is self-employed and losing work due to the virus; and any parents who aren't working from home. Unemployment insurance fund to be opened up to provide relief for a broad category of people affected by the growing list of restrictions as a result of the coronavirus.

• The Disaster Unemployment Assistance (DUA) program provides unemployment benefits to individuals who have become unemployed as a direct result of a Presidentially declared major disaster. In order to qualify for this, benefit your employment or self-employment must have been lost or interrupted as a direct result of a major disaster declared by the President of the United States. You must have been determined not otherwise eligible for regular unemployment insurance benefits (under any state or Federal law).

Department of Motor Vehicles

- On Thursday, March 19, all walk-in services will be paused and transitioned to phone and online services.
- On Monday, March 23, limited walk-in services will be available only by appointment at Concord, Dover, Manchester, Newport, and Twin Mountain. NH DMV non-commercial driver licenses and non-driver identification cards that are expired or set to expire between March 1, 2020 and April 30, 2020 are eligible for a 6-month extension.
